Message from the Chair

Dear Members and Supporters;

On behalf of dedicated community volunteers that comprise the board of directors at Manuels River it is my privilege and honour to offer a few words on the accomplishments of 2019. The successes of the past year are largely due to our hard working and talented group of management and staff as well as dedicated volunteers, board and committee members. Through their efforts Manuels River, including our world class interpretation centre, trails, programs and offerings, remained an essential part of the community's social, recreational, educational, tourism and business life. There were many highlights to our successful 2019, but I will mention a few.

The past year was the first full year under the leadership of our new Executive Director, Janet Rumsey. As expected, she brought a new energy, enthusiasm and perspective to this challenging role and her positive impact was evident throughout our operations.



In May, our Education Manager Gillian Davidge was honoured by the Canadian Association of Science Centres for Outstanding Project or Program Leadership – really putting Manuel River on the nationwide science map!

In June, we held our very first "Trails to Oceans Week" with variety of events. In August, a joint federal, provincial and municipal funding announcement meant that, combined with business and private donations, we were able to start construction of the next Phase of our multi-year Trails Master Plan. "Phase 2A" will complete about 1500 metres of upgraded and relocated trail within Ocean's Trail East from Blue Jay Bridge, past Bubble Pond, all the way to Worsley Park (quite literally a trail to the ocean). Much was accomplished before end of the year. The new and renewed sections of trail will be safer, wider and fully assessible for all including those in wheelchairs or using a stroller. We expect to complete Phase 2A by Spring of 2020. Future phases will be built as funding permits.

In July, on the what would have been the late Dr. Riccardo Levi-Setti's birthday, we recognized his contribution to physics and trilobite research by renaming our fossil exhibit area after him. Riccardo's extensive collection of Manuels River trilobites, including "MR1", forms the heart of our Centre's exhibits.

In December we completed an RFP process regarding our café and catering operations. As a result, we said a sincere "thank you!" to our former café operator Coffee Matters for over five years of service and we were thrilled to welcome the Soul Aztekas' team led by executive chef Mike Wozney and his wife Cinthia as café operator and exclusive Centre caterer. Catering began immediately and "Frida's Riverside Café" opened in February 2020!

We also continued to work hard in 2019 to continue to do more and do better in all areas, including school field trips, summer camps, events and admissions. Our 2019 Bobber Race Day, Giv'er on the River Fun Run, and our second "Chefs for Trails" event (including the new Fall Concert in partnership with the Town of CBS) were great successes that engaged the community on our new and improved trails!

Thank you, our members, volunteers and donors for supporting Manuels River.

I hope to see you at the Centre and on the Trails during 2020!

The development of Ocean Trail East allows users to walk past Blue Jay Bridge and walk toward Bubble Pond.






The development of this section of the trail reduces the risk of the fossil site being washed away through silting.



The trail development approach moved away from Bubble Pond in late fall and picked up the new trail development new Worsley Park and started to build the connection toward Blue Jay Bridge. This approach reduced travel distance for the vehicles pulling materials and made it possible to "connect the trails" to the ocean before trail development work stopped in December.

SCHOOL PROGRAMS

We launched our new winter map-themed/snowshoeing school programs in January 2019 (programs are for Grade 2, Grade 3 and Grade 5). Both map programs and snowshoeing components of the new school programs have been well received and the weather and trail conditions were favourable for most groups to get outside on the trails.

Our full-time Science Interpretation Team (Eleanor Power, Justin Smith and Madison Acker) do a fantastic job with the school programs. A number of participating teachers took the time to offer their unsolicited positive feedback.

The Gr. 3's absolutely loved the session today and I am sure they will be eager to come back with family in the near future! I am beyond excited to take the Gr. 1's as well! With all the knowledge you have to offer, they will be over the moon to learn about plants.

PALEONTOLOGY CLUB

As part of Supporting Curious Minds, we continued to offer a Palaeontology Club program, which was delivered once a month by our former Interpretation Staff member, Dr. Rod Taylor.

Spring Science Camp was offered over Easter School Break, with 5 themed days for children in Grades 1 to 5. In the summer we offered six weeks of Science Day camp. We alternated the age range for each week, having three weeks of camp for children that have completed Grades K to 2 and three weeks of camp for children that have completed Grades K to 2 and three weeks of camp for children that have completed Grades K to 5. Each day of the week had a different theme and the activities around each theme varied over the summer to keep returning campers engaged.

For young people that have aged-out of our regular summer science camp we offered a week long Leader-In-Training (LIT) camp for youth that have completed Grades 6 and 7. The LIT camp was facilitated by our Lead Science Interpreter, Eleanor Power, and focused on team-work and leadership skills development, as well as outdoor activities and games. The camp also included the option to complete the Canadian Red Cross Babysitting Course and to volunteer with our regular camps. We were very pleased with the camp uptake, with 13 youth participating in the full week LIT camp and an addition 9 youth signed up for the babysitting course. Many thanks to the VOCM Cares Foundation for their \$1000 donation to support the LIT camp.

We are very grateful that our entire Education Department is supported by multi-year funding from the Hibernia Management & Development Company.

Many of you know the story of Dr. Riccardo Levi-Setti and his work on trilobites and how the Manuels River fossils were the basis of his published research that demonstrated not only the actions of continental drift but processes of evolution itself. It was this story combined with the story of the Manuels River trilobite fossils, how they had been discovered over 150 years ago and were part of the history of the world that connected Newfoundland to Britain and North Africa, that convinced many individuals, business owners and government agencies to support the building of our Centre; giving us a place to display Riccardo's collection of fossils. Riccardo travelled the world, but Manuels River was the place where Riccardo chose as his final resting place. Together with his beloved trilobite fossils for eternity. The dedication of the fossil exhibit was our way to honor a brilliant man who was so committed to his work with fossils and to Manuels River.





INDEPENDENT AUDITOR'S REPORT

To: The Board of Directors of: Manuels River Natural Heritage Society Inc.

Opinion

I have audited the financial statements of Manuels River Natural Heritage Society Inc., which comprise the balance sheet as at December 31, 2019 and the statements of revenue, expenditures and net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In my opinion, the accompanying financial statements presents fairly, in all material respects, the financial position of Manuels River Natural Heritage Society Inc. as at December 31, 2019 and the results of its operations and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis of Opinion

I conducted my audit in accordance with Canadian generally accepted auditing standards. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of my report. I am independent of the organization in accordance with the ethical requirements that are relevant to my audit of the financial statements in Canada, and I have fulfilled my other ethical responsibilities in accordance with these requirements. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my opinion.

Responsibilities of management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error. In preparing these financial statements, management is responsible for assessing the organization's ability to continue as a going concern, disclosing, as applicable, matters related to a going concern and using the going concern basis of accounting unless management either intends to liquidate the organization or to cease operations, or has no realistic alternative to do so.

Those charged with governance are responsible for overseeing the Organization's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements.

My objectives are to obtain reasonable assurance about whether the financial statements as a whole are free of material misstatement, whether due to fraud or error, and to issue an auditor's report that includes my opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, I exercise professional judgement and maintain professional skepticism throughout the audit. I also:

Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Organization's internal control.

NOTES TO THE FINANCIAL STATEMENTS For the year ended December 31, 2019

1. Purpose of the Organization

The organization was incorporated on January 17, 1992 without share capital under the laws of Newfoundland and Labrador and received its charitable status on February 23, 2002. The organization is exempt from income taxes under section 149(1) e.

The activities of the Organization are restricted to those in furtherance of the following objects: To protect, enhance and preserve the entire Manuels River system, through wildlife habitat improvement, construction of an interpretation centre, the presentation of various educational programs and the development of a linear park.

2. Significant Accounting Policies

These financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations. Outlined below are those policies considered particularly significant for the organization.

a. Revenue recognition

The organization follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

b. Cash and cash equivalents

Cash and cash equivalents consist of cash on hand and bank balances.

c. Investments

Investments consist of Royal Bank of Canada Guaranteed investment certificates plus accrued interest.

d. Property and equipment

Property and equipment are recorded at cost. Amortization is recorded on the declining-balance basis at rates which will reduce the original cost to the estimated residual value over the useful life of the assets. In the year of acquisition, amortization is provided for at one-half the following rates.

e. Use of estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires the organization's management to make estimates and assumptions that affect the amounts reported in the financial statements and related notes to the financial statements. Actual results may differ from these estimates, however, such differences would not be expected to have a material impact on these financial statements.

f. Fair values of Financial Instruments

The organization has evaluated fair values of its financial instruments based on the current interest rate environment, related market values and current pricing of financial instruments with comparable terms. The carrying value of financial instruments is considered to approximate fair value, unless otherwise indicated.

g. Financial Instruments - Financial Risks

The organization is exposed to various risks through its financial instruments as follows: **Liquidity risk** The organization main liquidity risk relates to its accounts payable. **Credit risk** The organizations main credit risk relates to its accounts receivables.
