FROM THE CHAIR

Dear Members and Supporters,

For the second year in a row, all aspects of the operations and activities at Manuels River were impacted by the COVID-19 pandemic. Like the community in which we operate, we experienced the ups and downs of openings, closings, and changes in public health measures. First and second vaccine shots, booster shots, the NL VaxPass, Beta and Omicron variations, all became part of our everyday language.

I am proud to say that our Board of Directors, Executive Director, Janet Rumsey, management, staff, members and supporters all stepped up to help make 2021 a



successful year. Throughout this 2021 Annual Report you will read how Manuels River, despite the challenges of the pandemic, continued to deliver on our core mandate as it relates to conservation, education, recreation, and to continue to serve our community well. We had a successful second year for our Bobber Race 50/50 Online Lottery and we were able to hold another successful Giv'er on the River fun run. After a year's absence we were thrilled to hold another Chefs for Trails event and it was the best yet! This year saw the grand opening of the Community Rain Garden and the Survivor's Tulip Garden. We had a full year participating in the Meals Ready To Go program for seniors and for the second year the Town of CBS brightened everyone's winter with the lights display along the Manuels River Trails and Centre property.

We found time during the year to reflect on our operations and governance. We gained full control of Frida's Riverside Café and the Manuels River Catering operations under the leadership of our new Food and Beverage Manager. We transitioned Riverside Gifts to an online and "pop-up" store model. We updated our Purpose, Values and Vision statements and updated our policies and procedures as we continued to strive for good governance and excellence in everything that we do.

Plus, as you will see from our Treasurer's report, we managed to contain expenses and find new revenue sources including COVID-19 related government funding and for the second year in a row did not go into a deficit. That is a tremendous achievement. We plan to build on what we have learned in achieving our relative financial and operational success in 2020 and 2021 to bounce back even stronger in 2022.

We owe our thanks to Shelley Moores and Andrea Gosse, whose dedicated board service was especially valued as leaders regarding our special events and fundraising efforts. Both retired from the board during 2021 to successfully seek election to CBS Town Council. We wish them well as they continue to serve our community.

I want to thank our ED Janet and her hard working and talented group of management and staff, as well as our dedicated volunteers, board and committee members. Thank you to all of you who have continued to do all that you can during these challenging times to help keep Manuels River an essential part of the community's current and future social, recreational, educational, tourism, and business life.

Stay safe. I hope to see you at the Centre and on the Trails during 2022!

FROM THE EXECUTIVE DIRECTOR

Friends of Manuels River

As we turn the page to 2022, I want to pause and celebrate a year that was both transformative and historic for Manuels River. We have been committed to being flexible and open to change in the face of uncertainty. Our team has learned that the more adaptable we are, the more comfortable we are in embracing new ways of doing things; to remain relevant we have implemented many changes. I am so proud of my team over the last two years as they have adopted new workplace systems, new tools and new business strategies.



In 2021, strategic decisions were made to leverage each opportunity available to Manuels River, starting with taking over the entire food and beverage business for the first time since the centre opened; we no longer have a third party operator for the cafe or food catering. Another initiative was the creation of micro-weddings, offering an all-inclusive wedding package that our team plans and coordinates.

Our Education team got back to in-person learning with our STEM school programs, while our virtual offerings never stopped! To enhance our tourism offerings, we focused on the human history of Manuels River, expanded the exhibits with cultural and heritage displays plus we piloted a new guided heritage trail tour.

In June, we achieved another milestone for our trail development with the addition of our outdoor classroom. We did not plan to upgrade any of the trail sections in 2021; our focus was on maintaining the sections we had completed and maintaining the cleanliness and safety of the Canyon area. We also added an accessible picnic area around the centre to encourage visitors to sit and connect with nature.

In 2021, we expanded our programming to support at-risk seniors as well as new Canadians during the uncertainty of the ongoing pandemic challenges. We partnered with the Association of New Canadians and Connections for Seniors to serve our most vulnerable residents.

While we are proud of these accomplishments, we are also laser-focused on continuing to evaluate our programs, listening to our stakeholders, and providing even better programs and events. In the coming year we look to create stronger links to connect our proven programs to more schools, in-person as well as virtually, and offer programs to support remote communities as well as French schools.

It is undeniable that the COVID-19 pandemic has reshaped our organization. Leaders across our organization are all engaged; challenging us to adapt to meet the needs of the moment. At Manuels River, we're doubling down on what we've been doing and deepening our commitment to by providing access to experiential and deep-impact learning experiences for students and through our community programs. A taste of our programs and events are highlighted in this report.

I am inspired by how hard our team members work every day. Their dedication allowed us to achieve strong results in 2021. We are excited about the road ahead and believe that Manuels River is poised to have a great year in 2022. On behalf of our team, we are thankful for your partnership and support.

OUTDOOR CLASSROOM

Newly installed in 2021, our outdoor classroom allows us to spend more time outdoors with school groups that visit to participate in STEM education programming. By providing a stopping point along the trails where students can warm up and rest during an outdoor program, we can be outdoors longer and walk further with our groups. For example, this classroom, in conjunction with the new trail that has been developed to Worsley Park, will allow us to once again offer programs which start at the ocean and finish at the Interpretation Centre. This incorporates almost 2km of walking into the programs.

In addition to school groups, other programs will be able to use this space such as our youth group programs and our public programs. This will allow us to plan a program that involves hiking to the classroom, completing an activity there, and hiking back to the Centre - keeping participants outdoors and active the entire time. This was supported by the NL Community Healthy Living Fund.

TRAILS DEVELOPMENT

For the past two-plus years, the outdoors has been our saving grace. It is where we went to find peace in the uncertainty of our "new normal"; where restaurants turned to survive; where schools turned to allow outside programs; and where we turned to offer the majority of our tourism product offerings. With that embracing of the outdoors as a safe haven, has come a newfound respect for it, a new energy and valuing of the open spaces around us.

In spite of the pandemic, we completed Ocean Trail East in 2020 but due to lack of funding, we were not able to move forward with any further trail development in 2021.

We are pleased to share that we expect to move forward in 2022 with the development of The Canyon.

REIMAGINING THE CANYON

The pandemic undoubtedly surfaced an appreciation for an outdoor space, the space to do essentially everything we also do inside; eat, cook, entertain, work, play, and relax. We plan to reimagine the area known to this community as The Canyon. The Canyon is a popular space that is used by the community for a picnic and swimming; but it is not accessible to all visitors. Our vision is to open this space to make it accessible to everyone who wants to use it. The upgrading and development of the Canyon Trail will open up the geological and human history experience to our visitors.

Canyon Trail - Current State:

Currently, this segment of trail exists as a rugged path that allows for quiet reflection, constrained to able-bodied individuals and very small groups; therefore, some visitors/tourists are excluded because, beyond the T'Railway, the trail is not accessible to those using wheelchairs, strollers, or other mobility enhancing devices. We plan to elevate the trail standards to the same level as the newest developed sections.



This phase will enhance our trail system with **720 meters of accessible trail** and open up the natural history of The Canyon as well as the opportunities to for all visitors regardless of their physical limitations to enjoy the benefits of the open space.

RAIN GARDEN


A rain garden is a form of green infrastructure designed to withstand short-term flooding. A rain garden has loose, deep soil that absorbs and naturally filters rain and meltwater. This rain garden can reduce the amount of chemicals entering Manuels River, and eventually the ocean. It also provides habitat and food sources for bees, songbirds, and other wildlife.





DIGITAL PROGRAMS



Technological skills are becoming increasingly important in STEM education and careers. In order to improve digital skills we have continued to run our Maker Club for youth aged 9-12 that teaches participants how to use new forms of technology and alternative computer software and programming. Lifelong learning is a priority at Manuels River, so we deliver digital literacy programs for adults provided by ABC Life Literacy Canada.

HERITAGE PROGRAMS

In 2021, the education department focused on improving heritage education and programming. Our guided Heritage Tour that occurs on the upstream portion of our trails was updated during the summer of 2021. The tour now includes information on land use, recreational practices, and significant historical moments. In our exhibit, we introduced a new heritage board, a mural, and the model of the old Manuels River chalet. We ensured our adult workshops featured heritage education and this includes upcycling, macramé, foraged wreaths, rug hooking, and needle felting. Trailblazers, a youth program for ages 11-13, is a program that combines heritage and STEM. The program introduces participants to historical figures that contributed to science and ties it in through STEM activities. Teaching about local heritage is an important aspect of cultural conservation.

EXHIBIT RENOVATION

With support from the Canadian Heritage Museums Assistance Program, we were able to redesign and enhance our exhibit area with some new installations.

The stream table exhibit was relocated in the hallway outside the Education Lab. We installed a playhouse, affectionately called The Mini-Chalet, as it is in the style of our old chalet. This new space is for young children to play and discover an appreciation for science.

We also installed a new interpretive panel showcasing the Natural Heritage of Manuels River.





Participants were provided free transportation to and from the centre, free snowshoe rentals, an outdoor program, and a healthy snack or meal. This program was focused on reducing social isolation and improving youth mental health.

Many people who participated had not had an opportunity to leave the city of St. John's in over a year and some had not left St. John's since arriving from their country of origin. This was an opportunity for those individuals to participate in group activities and also have a chance to learn about the natural heritage of the province by learning about different plant species, participating in guided hikes to the fossil site and taking a tour of the fossil exhibits at Manuels River.











MEALS Ready To GO!

Meals Ready to GO! is a food security program that we started to support our vulnerable seniors during a time when there was so much uncertainty. Each week we prepare homemade, balanced meals that are given to seniors in need. To reach these individuals we partnered with Connection for Senior (CFS), a not for profit organization dedicated to providing emergency accommodations and services to adults in need. Our Manuels River catering team prepares the meals, our volunteers from the Rotary Club of Avalon Northeast package and seal the meals, and the staff from CFS distribute the meals. The communities that are served through this partnership with Connections for Seniors, are St. John's, Mount Pearl, Paradise, Goulds, Kilbride, Torbay, Portugal Cove-St. Phillips, and Conception Bay South. This year we produced and delivered 10,896 meals.




























MEALS Ready To Go has had a tremendous impact. Individuals experiencing homelessness are provided with nutritious, home-style meals while staying in CFS shelters. Individuals in the community benefit from food bank items as well as ready-made meals. This combination is particularly beneficial to seniors who have difficulty with cooking, live alone, live with disabilities, or who experience barriers to accessing food.

This program was completely funded in 2021 by grant opportunities as well as the generosity of our friends with Rotary and private donors. To continue this program we need to have community partners, private donations and sponsorships. The cost to run this program annually is over \$70K. 



TREASURER'S REPORT



On behalf of the Board of Directors of the Manuels River Natural Heritage Society Inc., I am pleased to present you with the 2021 Audited Financial Statements. This was our first year with our new auditor Brian T. Scammell, CPA and I must say the finance committee was impressed with the thoroughness of the audit.

The 2021 fiscal year was once again impacted by the downturn in the local economy and further negatively impacted by the COVID-19 pandemic. Although operational revenue created by Centre operations was up from 2020 by over \$300,000, as presented in the Schedule of Operational Revenue on page 13, I must point out on page 4 as shown in the Statement of Revenues and Expenditures that if it wasn't for \$239,

529 in Federal COVID funding we would have ended the year in a negative position with net of Expenditures over Revenues of (\$113,315). Also, in note 10, to the financial statements I must point out that we received a grant of \$100,000 from Heritage Canada late in the 2021 year and recorded it at that time as revenue, while expenses to use those funds will not be incurred until 2022. Thus, on page 4, Statement of Revenues and Expenditures, that \$100,000 grant is the main reason we were able to show Excess of Revenue over Expenditures of \$126,214. On a positive note, Bobber, Giv'er and Chefs for Trails were again great success stories attributable once again to wonderful collaboration between volunteers and staff. Overall, I am pleased to report that despite every obstacle encountered and thanks to a real team effort by staff and volunteers we ended the year in a positive position.

I would like to acknowledge the continued support from our key partners including the Town of Conception Bay South, Hibernia Management and Development Company Ltd., the federal and provincial governments, as well as our many donations and pledges from private and corporate supporters. As a result of the COVID-19 pandemic there were several federal and provincial subsidies and grants available in 2021 to organizations such as ours for which we are thankful, that our Executive Director Janet Rumsey and her team, to their credit, made themselves keenly aware of and availed of where appropriate.

I would like to acknowledge the dedicated efforts of our management and staff, volunteers, Board of Directors, and committee members, to continue to make Manuels River the continuing success story that it is. In particular in 2021, their efforts in contributing to the success of the Bobber Race Lottery, and Giv'er on the River, is to be applicated.

In conclusion let me once again express our sincere appreciation to all our stakeholders for their continued confidence in and support for our organization. Although undoubtedly 2022 will continue to be a challenge for us, particularly in the first half of the year with COVID still impacting our operation, I am confident with Janet's strong leadership and everyone's support we can get through 2022 once again unscathed.

INDEPENDENT AUDITOR'S REPORT

To the Members of Manuels River Natural Heritage Society Inc.

Qualified Opinion

I have audited the financial statements of Manuels River Natural Heritage Society Inc. which comprise the statement of financial position as at December 31, 2021, and the statements of revenues and expenditures, changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In my opinion, except for the possible effects of the matter described in the *Basis for Qualified Opinion* section of my report, the accompanying financial statements present fairly, in all material respects, the financial position of the Organization as at December 31, 2021, and the results of its operations and cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations (ASNPO)

Basis for Qualified Opinion

In common with many not-for-profit organizations, the Organization derives revenue from fundraising activities the completeness of which is not susceptible to satisfactory audit verification. Accordingly, verification of these revenues was limited to the amounts recorded in the records of the Organization Therefore, I was not able to determine whether any adjustments might be necessary to fundraising revenue, excess of revenues over expenses, and cash flows from operations for the year ended December 31, 2021, current assets and net assets as at December 31, 2021

I conducted my audit in accordance with Canadian generally accepted auditing standards. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of my report. I am independent of the Organization in accordance with ethical requirements that are relevant to my audit of the financial statements in Canada, and I have fulfilled my other ethical responsibilities in accordance with these requirements. I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for my qualified audit opinion.

Other Matter

The financial statements for the year ended December 31, 2020 were audited by another auditor who expressed an unmodified opinion on those financial statements on March 19, 2021.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with ASNPO, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Organization's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Organization or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Organization's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, I exercise professional judgment and maintain professional skepticism throughout the audit. I also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for my opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

1. NATURE OF OPERATIONS

Manuels River Natural Heritage Society Inc. (the "Organization") was incorporated on January 17, 1992 without share capital under the laws of the Province of Newfoundland and Labrador and received its charitable status on February 23, 2002. The Organization is exempt from income taxes under section 149(1) e.

The activities of the Organization are restricted to those in furtherance of the following objects: To protect, enhance, and preserve the entire Manuels River system, through wildlife habitat improvement, construction of an interpretation centre, the presentation of various educational programs and the development of a linear park.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO).

Cash and cash equivalents

The Organization's policy is to present bank balances and term deposits with a maturity period of three months or less from the date of acquisition under cash and cash equivalents.

Financial instruments

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

Investments

Investments consist of investment certificates which is recorded at cost plus accrued interest.

Inventory

Inventory is valued at the lower of cost and net realizable value with the cost being determined on a first-in, first-out basis.

Capital assets

Capital assets are stated at cost or deemed cost less accumulated amortization and are amortized over their estimated useful lives on a declining balance basis at the following rates and methods:

Bridges	4%	declining balance method
Buildings	4%	declining balance method
Furniture and fixtures	20%	declining balance method
Parking lot and trails	8%	declining balance method
Signs	20%	declining balance method
Computer equipment and software	55%	declining balance method

The Organization regularly reviews its capital assets to eliminate obsolete items. Government grants related to the purchase of capital assets are treated as deferred capital contributions and amortized over the same period as the related assets.

Capital assets acquired during the year but not placed into use are not amortized until they are placed into use.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Revenue recognition

The Organization follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Revenue from catering, bar and gift shop sales, admissions, facility rental, grants, programs and membership is recognized when received or receivable if the amount to be received can be reasonably estimated and collection is reasonably assured.

Revenue from fundraising activities is recognized when received.

Contributed services

The operations of the organization depend on both the contribution of time by volunteers and donated materials from various sources. The fair value of donated materials and services cannot be reasonably determined and are therefore not reflected in these financial statements.

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

Otherwise, an interest rate of 5% will apply to the balance, which will be repayable in 36 monthly blended payments, maturing on December 31, 2026. Since there is reasonable assurance that the Organization will repay \$40,000 by December 31, 2023, \$10,000 was recognized in net income in 2020 and an additional \$10,000 in 2021. The liability resulting from the \$40,000 balance was initially recognized at its fair value of \$40,000.

9. FINANCIAL INSTRUMENTS

The Organization is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Organization's risk exposure and concentration as of December 31, 2021.

Credit risk

Credit risk arises from the potential that a counter party will fail to perform its obligations. The Organization is exposed to credit risk from customers. The Organization has a significant number of customers which minimizes concentration of credit risk.

Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The Organization is exposed to this risk mainly in respect of its receipt of funds from its customers and other related sources, long-term debt, and accounts payable.

Unless otherwise noted, it is management's opinion that the Organization is not exposed to significant other price risks arising from these financial instruments.

10. COVID-19 PANDEMIC

Governments have imposed measures to contain the outbreak, including business closures, travel restrictions, quarantines and social distancing measures. The spread of the COVID-19 virus has resulted in a sharp decline in global economic growth as well as causing increased volatility in financial markets.

10. COVID-19 PANDEMIC (continued)

The Organization continues to take measures to mitigate the effects of the current crisis. The Organization was eligible for subsidies under the Canada Emergency Wage Subsidy Program, of which \$63,490 has been recognized as revenue in the year. (2020 - \$110,210) The Organization also recognized revenue of \$28.015 in 2021 under the Canada Recovery Hiring Program.

Manuels River Natural Heritage Society Inc. received \$100,000 in 2020 and \$100,000 in 2021 from Heritage Canada under the Museums Assistance Program, Reopening Fund for Heritage Organizations Component. \$148,024 was recognized as revenue in the year. (2020 - \$51,976).

With respect to the \$100,000 received in 2021 from Heritage Canada, the funds were received late in 2021. While this funding was recognized as revenue in 2021 as there were no basis to defer it under the funding approval letter, expenses to use those funds will not be incurred until fiscal 2022.

Finally, the Organization received Canada Emergency Business Account loans of \$20,000 in 2021 and \$40,000 in 2020. Additional details are provided in Note 7.

11. ECONOMIC DEPENDENCE

The Organization's ability to operate each year is dependent on its ability to secure funding from private and/or government sources.

12. COMPARATIVE FIGURES
